The Village of Goehner Board of Trustees met in open and regular session on February 5, 2019, at the Goehner Fire Hall, as posted in three places in the Village. The meeting was called to order by Vice-Chair Wagner at 7:32 p.m., at the Goehner Fire Hall. Upon roll call, the following board members were present: Dodson, Ostrander, Meinberg and Wagner. CONSENT AGENDA: Trustee Ostrander moved to approve the consent agenda, with second by Trustee Dodson. No discussion. RCV: Aye-Trustee Dodson, Ostrander, Meinberg and Wagner. Motion carried.

STREET HEARING: The street hearing was opened at 7:40 and documents were available for review.

NUSIANCE PROPERTIES: None.

TRAFFIC: Speed regulations through town. Need to address Semi's using May street through town to properties to the north. Will make a request that the use Front street instead.

STREET HEARING: Meinberg with second by Ostrander moved to close the street hearing at 7:41. No discussion. RCV: Aye- Trustee Dodson, Ostrander, Meinberg and Wagner. Motion carried. Ostrander introduced Resolution 241 with second by Meinberg. No discussion. RCV: Aye-Trustee Dodson, Ostrander, Meinberg and Wagner. Motion carried.

Village Clerk Janice Nitz read ordinances 244 through 252 in condensed form. Trustee Ostrander made a motion to accept Ordinances #244 through 251 (with the exception of #252 that is being held over for the March meeting for further review) as read and moved that the statutory rule requiring reading on three different days be suspended. Trustee Dodson seconded the motion to suspend the rules. No discussion. RCV: Aye-Trustee Dodson, Ostrander, Meinberg and Wagner. None voted Nay.

The motion to suspend the rules was adopted by three-fourths of the Trustees and the statutory rule was declared suspended for consideration of said ordinances.

Trustee Meinberg made a motion to approve said ordinances with the exception of ordinance 252 pulled for further review with second by Dodson. No discussion. RCV: Aye-Trustee Dodson, Ostrander, Meinberg and Wagner. None voted Nay.

Acting Chairperson Wagner declared Ordinances #244 - #251 adopted. Said ordinances were then moved for final passage by Dodson, motion was seconded by Ostrander. RCV: Aye-Trustee Dodson, Ostrander, Meinberg and Wagner. None voted Nay.

The passage and adoption of said ordinances having been concurred in by a majority of all members of the Board of Trustees, the Vice-Chairperson declared the ordinance adopted and the Vice-Chairperson, in the presence of the Board of Trustees, signed and approved the ordinance. The Clerk attested the passage and approval of the same and affixed her signature thereto.
